

General Norms for " Not Allowing " the use of Municipal School Room/Halls of Ground for various activities ."

1. No permission will be granted for use of Municipal school Rooms and Halls for conducting Tuitions/Coaching classes.
2. Rooms and Halls shall not be allowed for any type of religious activities except Marriage Ceremony.
3. Rooms,Halls, and grounds shall not be allowed for any type of political activities.
4. Rooms,Halls and Grounds' shall not be allowed for any exhibition which is for commercial purpose.
5. Rooms shall not be allowed to any Union of the B.M.C. or any outside organisation/Institutions for office purpose.
6. Rooms,halls, and ground shall not be allowed for Medical Check-up,eye- Camp,blood donation and Dental etc. Camp organised shall for general public.
7. Rooms,Halls and grounds shill not be allowed for conducting Judo-Karrate Classes or any Form of Martial Arts classes.
8. Grounds shall not be allowed for conducting Night Cricket Competition,
9. Grounds shall not be allowed for Tamasha,Loknatya,Dandya-Garhha Ras etc.
10. Ground shall not be allowed for conducting wrestling competition.
11. Grounds shall not be allowed for conducting Circus.
12. Rooms,Halls and grounds shall not be allowed for preparing and storing any type of idels.

norms proposed for allowing the use of rooms and halls Municipal Schools for Social Activities.

- 1) Permission to use rooms/Halls will be granted to the Registered Educational Institutions and Registered Organisations only.
2. Permission to use rooms/Halls at only Municipal owned school bldg. where M.C.T. or custodian are provided for safety of school premises/property will be given.
3. Permission will be granted subject to availability of accommodations required by the Institutions/Organisations.
4. Permission will be granted <sup>on</sup> to the following Social Activities after school hours and/Sundays and Holidays--
  - A- For meetings of Registered Organisation as well as meetings of Municipal Recognised Union and Co-op.Housing Societies of Municipal Employees.
  - B- For exhibitions ( non -commercial ),Photography books or on the lives of imminent personalities,Rangoli Exhibition etc.
  - C- Lectures on Social Problems etc.
  - D- For marriage purpose only on Sundays and holidays and during summer and Diwali Vacations period.
  - E- For lodging purpose during holidays and vacation periods only for the students coming to Bombay on Educational Tour,for lodging the participants of the Govt.bodies coming here for conferences etc. or for players participating in Kabbadi,Khokho etc. tournament held at State level.
  - F- For free distribution of such school uniforms and Text Books,note books,exercise books to Municipal School children as well as to poor and needy children of the locality during or after the school hours and on Sundays and holidays.
  - G- For Toy Libraries for the children.
  - H- For conducting the Yoga Classes.

Norms proposed for allotment of the rooms and Halls of Municipal Schools for Cultural activities.

1. Permission to use rooms/Halls will be granted to the registered Educational Institutions and registered organisations only.
2. Room/Hall in only Municipal owned Schools building where I.C.T. or custodians are provided for safety of school premises/properties-- will be given.
3. Permission will be granted subject to availability of accommodation required by the Institutions/Organisations .
4. Permission will be granted to the following activities :
  - A- For Drama Competitions.
  - B- For Drama Rehearsals.
  - C- For Reading Poetry Competitions.
  - D- For small gathering purpose/Get-together.
  - E- For Seminars and non-educational lectures related to the Cultural activities.
  - F- For educational film shows, Municipal programme (non-Commercial).
  - G- For film shooting.
5. All the above activities will be permitted after Municipal school working hours i.e. from 6.00 p.m. to 10.00 p.m. and/or Saturdays after school working hours and on Sundays and holidays.
6. Ask For all permissions upto three days the party shall sign I.L.E condition form for accepting our terms and conditions mentioned in it and for all permission above three days the Party shall execute an Undertaking on Rs. 10/- Stamp paper accepting our terms and conditions as per conditions.

Norms proposed for allowing the use of grounds of Municipal School for Sports Activities :-

1. Permission to use grounds will be granted to the Registered Educational Institutions ; other Registered Organisations and Clubs affiliated to sports Bodies of the State Government.
2. The grounds of Municipal owned schools only where M.C.T. or Custodians are provided shall be allowed to be used.
3. Permission will be granted subject to availability of accommodations required by the Institutions/Organisations.
4. Permission will be granted to the following activities:-
  - A- Use of Municipal School grounds after Municipal school working hours or on Sundays,holidays for Sports Tournaments held by Educational Institutions or by organisations as stated Sr. NO.1. above.
  - B- For children physical programme exclusively for children of Registered Educational Institutions.
  - C- For sports practice by children of Educational Institutions and by Registered Organisation as mentioned in Sr. NO.1. above.
5. For parking Ambulances only of any Social Registered Organisation.

Norms proposed for allowing the use of rooms and Halls of  
Municipal Schools for Medical Activities :-

1. Permission to use rooms/Halls will be granted to the Registered Educational Institutions and Registered Organisations only.
2. Permission to use rooms/Halls in only Municipal owned school bldg. where M.C.T. or Custodians are provided for safety for school premises/properties will be given.
3. Permission will be granted subject to availability of accommodation required by the Institutions/organisations.
4. The premises will be allowed to be used for Medical check up camp, E.N.T., Check up, Dental Camp and distribution of spectacles etc. for benefit of Municipal school children only, Such Camps should be during Municipal School hours and subject to consent of parents.
5. No medication will be given to Municipal School children in the Municipal premises without consultation of M.O. (schools).

Norms purposed to allot the rooms and halls of Municipal School premises for

EDUCATIONAL ACTIVITIES.

1. Permission to use rooms/Halls will be granted to the Registered Educational Institutions and Registered Organisations only.
2. The objective of the Institutions and Organisations must be provide education to poor children in the vicinity.
3. Rooms/Halls in only Municipal owned school bldg. where M.C.T. or Custodians are provided for safety of school premises/properties,will be given.
4. Permission will be granted subject to availability of accommodations required by the Institutions/organisations.
5. Only one Institution/Organisation will be allowed to use the Municipal School premises at a time subject to condition laid down at Serial NO.4. above.
6. Permission will be granted for the following activities..
  - A) For conducting day school during Municipal school working hours.
  - B) For conducting Night schools/Junior Colleges subject to production of E.I .G.B. 's permission letter for conducting the Night High School/Jr. College by the Institutions,
  - C) For conducting Reading -cum-study room where children will study on their own.
  - D- For conducting Balvadi Classes.
  - E- For conducting Adult Education Classes.
  - F- For conducting Civil Defence Classes.

- C- For conducting Socio-Educational activities relating to upliftment of the poor and needy students/children of our Municipal Schools or for the benefit of the other needy children in the Society, Slums etc. during the day time, as well as for Toy Libraries etc.
- H- For conducting S.S.C. Vyakhyanmala.
- J- For conducting Free Hindi Classes.
- J- For conducting examination Centres of the Examinations held by any Government bodies, Non-Government Bodies, B.M.C. and for examination Centres of Hindi Classes.
- K- For conducting Elocution and Essay Competitions etc.
7. All the activities except A,D and G mentioned above will be allowed to be conducted after Municipal school hours i.e. 6 p.m. to 10 p.m. on Saturdays after Municipal School working hours and on Sundays and holidays.
8. If the activity will run for a longer period the permission for the same will be granted on yearly basis i.e. during the said academic year and will be renewed subject to availability of accommodation.
9. All the temporary permissions will be granted at the most two months in advance and minimum Ten days in advance.
10. For all permissions upto three days the party shall sign the condition form concerned accepting our terms and conditions mentioned in it and for all permission above three days the party shall execute an Undertaking on Rs. 10/- stamp paper accepting our terms and conditions as per conditions.
