Examining this issue in the context of some aspects of the political economy of the development planning and policy processes, it is shown that even the understanding of poverty was designed as a special purpose vehicle for showing that the application of the growth fundamentalist brand of development economics necessarily shows some quantitative but volatile 'progress' in poverty reduction while, in practise, it exacerbates the processes, institutions and forces that make the Indian poverty an ever stronger manifestation of the multi-faceted phenomenon of social exclusion. Based on an alternative concept and understanding of development, the present quick overview of the Indian' development' experience, comes out with some alternative policies needed for making poverty history over a reasonable time horizon and in a manner that simultaneously guarantees livelihood adequacy and security in an increasingly egalitarian social framework.
